*A member of your family just died and has been taken to the mortuary space “les Oliviers” in Ranguel Hospital **under the judicial authorities.***

Please find hereafter some information to help you to achieve the administrative formality that will help you to bring the corpse out of the mortuary.

In any case please stay in contact with the Police station who is in charge with the medico-judicial proceedings.

CORPSE DISPLAY

When the corpse is under a medico-judicial proceeding, to present the corpse is strictly

under control and need the permission from the appropriate Authority.

You can see the corpse after you have been given the permission by Judicial Authorities.

BURIAL CERTIFICATE

It will be given to the family by the Police station under identity card.

CORPSE EXIT

When the burial certificate has been delivered to you : go to the Town hall where the person died (births and deaths registration office : “Etat Civil” office).
Please bring it and your family record book as an identity card.

You will be given a death certificate and the authorization to close the coffin that you have to give to the Funeral Director you have chosen (they will organise the departure of the corpse out of the Mortuary).

STAY EXPENSES

According to the local law n° 97-103 (1997 november, 14th) : after 3 days of the death certificate

delivery, the family whom corpse still stays in the mortuary space will be charged with fee.

PEOPLE CARRYING PROSTHESIS WITH BATTERY

According to the local laws n° 98-635 (1998, July 20th) and modifying the previous municipal laws the prosthesis with battery has to be removed before the

burial. This decision has to be taken by the family member who has the power of the burial. You can ask the Funeral Director.
